**The test application will be available on our website [www.eafsc.com](http://www.eafsc.com). Tests offered: Pre-Preliminary thru Preliminary Moves in the Field and Free skate test levels, Preliminary thru Bronze Partnered Dance (skater will have to provide their own partner), and Preliminary thru Gold Solo Dance.**

**Test forms are to be received by 8:00 p.m. on November 18, 2020. The test application must be filled out entirely and mailed or given to the Test Chairperson, Mary Gauthier. All late applications will be put on a waiting list and will be taken as time permits, a \$25.00 late charge will be assessed.**

**Masks are required in the Hannahville Ice & Turf Complex. Please adhere to CO-VID guidelines with proper distancing of at least six feet. Locker rooms will not be available. Please wear skating attire to the rink. Seating with proper distancing will be provided to skaters to put skates on. If state guidelines change due to the CO-VID and EAFSC is unable to provide a testing session, full refunds will provided.**
